Terms and conditions of the academy summer camp contract

These General Terms and Conditions of the academy summer camp contract are an integral part of the academy's contracts entered into by the students' legal representatives (mother, father, guardians, tutor etc.), hereinafter: "contract partners", with Learning First British School SL (NIF: B42993535 located at Calle la Caridad 59/63, Tacoronte), respectively, hereinafter: "LFT". These general terms and conditions apply to the summer camp programme at LFT. By registering for this programme, the contract partners declare their agreement with these General Terms and Conditions of Contract and are bound by them.

1. Contract and obligations of the contracting parties

- a. The summer camp contract is valid upon being signed by both the Contract Partners and an authorised LFT representative, either in person or via the online registration form.
- b. Contract Partners are jointly and severally liable for the obligations arising from this agreement, regardless of any change in civil status.
- c. Contract Partners confirm acceptance of the academy's internal regulations, code of conduct, and handbook.
- d. The contract is valid from the registration date until the student's final day at the LFT Summer Camp.

2. Contract and obligations of LFT

- a. The 2025 Summer Camp runs for 7 weeks, from 23rd June to 8th August.
- b. Classes are led by qualified educators using modern, communicative methods focused on speaking and listening skills (not reading or writing).
- c. All camp staff communicate exclusively in English.
- d. Age group expectations:
 - Ages 3–5: No English required.
 - Ages 6–8: Very Basic English expected.
 - Ages 9–10: Should have some familiarity with English.
 - Ages 11–13: Expected to speak short sentences.
 -
- e. LFT reserves the right to assign or replace staff members (teachers, assistants, cooks, cleaners, etc.) as needed.
- f. All staff are qualified and certified to work with children.
- g. At least two staff members are certified in first aid.
- h. Students are placed into classes by LFT. There is no guarantee of assignment to a specific teacher.
- i. Only children aged 3–13 may register.
- j. Registration does not guarantee the achievement of specific educational outcomes.

k. All registration, data protection, and payment forms must be completed prior to attendance.

3. **Summer Camp Hours:**

- Camp hours are Monday–Friday, from 09:00–13:00 or 09:00–15:00.
- A supervised Breakfast Club begins at 07:30 (included in the fee), but no structured activities begin until 09:00.
- Children must be collected on time. A late pick-up fee of €12 per 20 minutes will apply.

4. **Summer Camp Projects:**

- The camp follows a project-based learning model combining creativity, imagination, sports, cooking and orientation activities.
- One new project runs each week (7 in total). Projects are assigned by LFT.
- Activities may change due to weather, scheduling, or unforeseen circumstances. LFT reserves the right to cancel or modify as necessary.

5. **Breakfast and Lunch (Meals):**

- Meals are prepared by a certified cook. No seafood or peanuts are served due to allergy risks.
- Meals are served by staff with valid food handling certificates.
- Students staying until 15:00 must eat the provided lunch — no external food allowed.
- Students may bring their own breakfast (excluding seafood or peanuts).
- All meal times are supervised by LFT Staff
- Menus will be shared prior to the start of camp.

6. **Personal Property**

- Students must bring: a change of clothes, towel, swimsuit, indoor sandals, sunscreen, a hat, and a labelled water bottle.
- Electronics and valuables (phones, tablets, iPads, AirPods, cameras, etc.) are not permitted.
- Toys or other personal items should not be brought to camp.
- LFT is not responsible for loss or damage of personal belongings.

7. **Dress code:**

- Students should wear comfortable clothes and shoes (e.g., T-shirts, shorts, trainers).
- Open-toe shoes are not allowed. Crocs may be worn indoors; trainers are preferred for outdoor play.

8. Behaviour:

By signing the contract, Contract Partners agree to support LFT staff in enforcing the camp's behavioural expectations and to explain these to their child in advance. Repeated or serious misbehaviour may lead to temporary suspension or permanent removal without a refund.

Expected behaviour includes:

- Walking indoors, no running.
- No touching of animals without permission
- Following staff instructions
- Listening respectfully
- Respecting peers, staff, and property
- Staying in supervised areas

Grounds for immediate dismissal include:

- Violence or threats to others
- Bullying, name-calling, or offensive language
- Vandalism
- Discrimination of any kind (racial, sexual etc.)

9. Summer Camp Fees:

- a. Fees vary based on attendance. See the pricing table on pages 3–4.
- b. Materials are included in the camp fee.
- c. LFT students enrolled since October 2024 receive priority registration.
- d. A 10% discount applies on camp fees to LFT students enrolled since October 2024 who register for 5 or 7 weeks (09:00–15:00 schedule). The discount does not apply to breakfast or lunch.
- e. The €90 + 7% IGIC registration fee is non-refundable.
- f. Excursion costs are not included and will be notified and charged separately.

10. Financial provisions/terms of payment:

- a. A non-refundable registration fee of €90 + 7% IGIC is due at signing.
- b. The registration fee will be charged within 3–4 working days after contract signing.
- c. Full camp fees will be charged between 23rd–30th June 2025.
- d. Payment is via direct debit only.
Failed payments will be re-attempted after 3 business days with a €12 fee.

- e. Continued non-payment after two attempts and a 3-day grace period may lead to the student being excluded from camp.
- f. LFT may terminate the contract and charge an administrative (€90) and cancellation fee (50% of the remaining balance), plus fees for days already attended.
- g. Debt recovery proceedings may be initiated as needed.
- h. Missed days are non-refundable or recuperable.
- i. No alternative payment schedules are accepted (e.g., no weekly payments).

11. Cancellation:

- a. In an event that due to circumstances beyond the control of LFT, including any urgent government instructions, or cause of force majeure (natural disaster, war, health emergency including a pandemic or any outbreak of a pandemic) arising after the signing of the summer camp contract, and if it becomes necessary to establish additional hygiene, mobility restrictions, health, sanitary or safety measures that may force the suspension of the summer camp.
 - I. LFT will provide the option to transfer your registration to summer 2026 or offer a full refund (minus the 90€ + 7% IGIC registration fee and any summer camp tuition already provided) of the camp fees in these circumstances.
 - II. If the contracted partner chooses to transfer the fee to the summer camp 2026 programme, the remainder of the fee paid will be deducted from the new 2026 fees.

11.1 Cancellations before 31st May 2025

- a. **Certified medical reasons:** If cancellation is requested before 31st May 2025 and is supported by a doctor's written explanation, no additional fees will be charged. However, the €90 registration fee + 7% IGIC is non-refundable.
- b. **Any other reason:** If cancellation occurs for non-medical reasons before 31st May 2025, a €90 administrative fee will be charged. The €90 registration fee + 7% IGIC remains non-refundable.

11.2 Cancellations after 31st May 2025

- c. **Certified medical reasons:** For cancellations after 31st May 2025 supported by a doctor's written explanation, no additional fees will apply. The €90 registration fee + 7% IGIC is still non-refundable.
- d. **Any other reason:** If cancelled for non-medical reasons after 31st May 2025, 50% of the remaining summer camp fee will be charged. The €90 registration fee + 7% IGIC is non-refundable.

11.3 Cancellations between 10th – 22nd June 2025

- a. **Certified medical cancellation:** With a valid doctor's note during this period, 50% of the remaining summer camp fee will be charged. The €90 registration fee + 7% IGIC remains non-refundable.
- b. **Any other reason:** During this time will incur a 75% charge of the remaining summer camp fee. The €90 registration fee + 7% IGIC is non-refundable.

11.4. Cancellations on or after 23rd June 2025

- a. **After camp has started:** No refunds will be issued for cancellations once the camp has begun. The €90 registration fee + 7% IGIC is non-refundable.
- b. **After 23rd June, but before or after camp begins for the contracted partner:** Any cancellation from 23rd June onwards, even if the camp date has not started for the contracted partner, will result in 100% of the total summer camp fee being due. The €90 registration fee + 7% IGIC is non-refundable.

12. Extraordinary termination of contract by LFT:

LFT may terminate the agreement without refund if:

- The student seriously breaches camp rules (see Section 8)
- The student repeatedly fails to attend without notice
- The partnership becomes unreasonable to continue

LFT reserves the right to charge fees for tuition already provided, plus a €90 administrative fee.

13. Lesson times, school holidays and public holidays:

- LFT will provide a timetable and notify Contract Partners of national or local holidays in advance. Holidays are observed accordingly. The

14. Absences:

- a. Contract Partners must notify LFT of absences (email, phone, or in writing).
- b. **Missed days are non-refundable and will not be rescheduled unless cancelled by LFT.**

15. Insurance and Medical Assistance:

- a. **Students must have valid public and/or private health insurance in Spain.**
- b. LFT has student accident insurance via Mapfre.
- c. LFT Staff do not administer medication, except emergency meds (e.g., EpiPens, inhalers). Inform staff if such medication is in your child's bag.
- d. In emergencies, LFT is authorised to seek medical care until a parent/guardian can be reached.

- a. LFT is not liable for personal injury, property loss, or financial damages except where required by law.
- b. LFT reserves the right to cancel summer camp activities if there are insufficient students or other circumstances that make it unreasonable to expect LFT to carry them out. Furthermore, LFT reserves the right to make changes to the summer camp projects for important reasons while safeguarding the legitimate interests of registered students.

17. Final provisions:

- a. If any part of this agreement becomes invalid, remaining clauses remain in force.
- b. All amendments to this contract must be in writing or via email.
- c. Spanish law governs all contractual relationships, with Jurisdiction in Tacoronte, Tenerife, Spain.

18. Data Protection:

In accordance with the Organic Law on the Protection of Personal Data and Guarantee of Digital Rights (LOPDGDD 3/2018) and with the General Data Protection Regulation (RGPD EU 2016/679), we inform you that the personal data that could be included in this document or those that may be collected in the course of the relationship will be included in the files owned by Learning First British School SL. They may be communicated to third parties exclusively for the provision of the agreed service. The purpose of processing such data is to establish a contractual relationship with this Company. Legitimation is done through the consent of the interested party. You can exercise the rights of access, rectification, opposition, limitation, portability and deletion in the terms provided in current legislation or consult additional and detailed information on Data Protection by contacting the company.
