Terms and Conditions of the Academy Contract for All Courses, Group Classes, Individual Classes, and Homework Support Classes

These General Terms and Conditions of the academy contract form an integral part of the academy contracts entered into by the student or their legal representatives (parents, guardians, etc.), hereinafter: “contracting partners”, with Learning First British School SL (NIF: B42993535, with registered address at Calle la Caridad 59 and 63, Tacoronte), hereinafter: “LFT”.

They apply to all study courses at LFT. By registering for a course of study, the contracting partners declare their agreement with these General Terms and Conditions and are bound by them.

Certain LFT services may be subject to separate contractual terms and/or registration forms, which supplement the provisions of these General Terms and Conditions (for example, camps and overseas trips). These are stated separately in connection with the respective service. Where these separate and special conditions for individual service areas deviate from the provisions of these General Terms and Conditions, the provisions of the special conditions shall prevail over the respective provisions of these General Terms and Conditions.

1. Contract and Obligations of the Contracting Parties

- a. The academy contract is accepted upon the signature of both the contracting partners and the representative of LFT.
- b. The contracting partners are jointly and severally liable for the obligations they assume through the academy contract. This joint liability is not affected by any later change in civil status
- c. The contracting partners remain liable for obligations under this academy contract even if the student reaches the age of majority.
- d. The contracting partners agree to comply with the academy’s rules, code of conduct, and handbook.
- e. The contract is a rolling contract and will remain valid each academic year until the contracting partners and/or LFT decide to cancel it.

2. Contract and Obligations of LFT

- a. All academic courses at Learning First Tenerife have a duration of 10 months (September – June).
- b. Academic courses run from 8 September 2025 to 19 June 2026.
- c. Intensive courses and individual classes last 3–4 months; start/end dates are set before the first class.
- d. Homework support classes have an initial duration of 2 months; start/end dates are set before the first class. After 2 months, students may book on a monthly basis.
- e. Classes are delivered by qualified teachers using modern teaching methods.
- f. LFT is responsible for staffing and organising classes and may change teachers during the contract. There is no entitlement to a specific teacher, timetable, or classroom.
- g. Acceptance of the academy contract does not guarantee the achievement of the desired educational objective.
- h. LFT may register students for official language, music, or mathematics exams, but reserves the right not to enter them if teachers deem them unprepared.
- i. If class methods must change (e.g., to remote learning) due to official instructions, pandemics, similar events, or force majeure, the classes will be deemed delivered with no right to reduction or refund.
- j. Registration, data protection, calendar, and direct debit forms must be completed and signed before attending the first class.
- k. Any updates to the terms and conditions will be emailed to the contracting partners.

3. Fees / Updated Fees for New Academic Years

- a. Course costs are revised annually, based on previous LFT results, relevant rates, market resources, and inflation, and adjusted accordingly.
- b. New fees are deemed accepted and become part of the renewable contract unless the contracting partners terminate for the following year by email or letter with three months' notice before the end of the school year (19 June 2026). Late cancellation will incur three months' fees according to the updated price list.
- c. If a student joins during the academic year, fees are prorated from the joining month. Registration is still payable in full as per section 4.
- d. Teaching materials are included in registration; student books are not included and must be purchased before the first class.
- e. The registration fee is non-refundable and will be charged 3–4 working days after both parties sign the contract.
- f. Costs for excursions, trips, camps, exams, exam administration, certificates, and other additional services are not included in the course cost.

4. Enrolment of New Students

- a. New students (adults or minors) enrolling in any course at LFT have a trial period of 4 weeks, counted as calendar days (28 days).
- b. A new student is any person who has not attended a course at LFT in the previous 5 years.
- c. If the contracting partners choose to withdraw from the course within this 4-week trial period (28 calendar days), they may cancel and will only pay for the classes attended.
- d. If the contracting partners choose to withdraw within the 4-week trial period, the registration fee and any money paid for books will not be refunded.
- e. If a student starts a course between the 1st and 14th of the month, the full monthly course fee for that month will be charged. If a student starts between the 14th and 31st of the month, 50% of the monthly fee will be charged.
- f. The registration fee is reduced to 50% if a student starts a course in May of the academic year 2025/2026, but the full registration fee will be payable again for the following academic year.

5. Financial Provisions / Payment Terms

- a. The registration fee is a one-time payment at the start of the course each year and is non-refundable. It applies to all courses, groups, individual classes, homework support classes, and intensive courses.
- b. The course fee is charged monthly, even when there are local, national, or school holidays, and regardless of whether there are 4 or 5 weeks in the month.
- c. All payments must be made exclusively by direct debit.
- d. The monthly payment will be debited from your account during the first week of each month, between the 1st and the 7th. Approximate payment dates are:
 - 17 September 2025
 - 3 October 2025
 - 3 November 2025
 - 3 December 2025

e. If your direct debit payment is returned, we will attempt to charge again within three business days and a €6 bank fee will apply. If the bank fee exceeds €6, we will charge 6% of the returned balance, up to a maximum of three times.

f. If a monthly fee is not paid within the agreed time frame and LFT has not collected the sum after three attempts, LFT has the right to exclude the student from classes until all outstanding fees are paid. A payment reminder will be sent, granting a 10-day grace period to settle the overdue payment.

g. If payment is still not made after the reminder and grace period, LFT may terminate the contract. In this case, LFT is entitled to an administrative fee (€80) and a cancellation fee equivalent to three months of course fees, in addition to the registration fee. If legal action is required, all associated costs will be borne by the contracting partner, and LFT will charge 3% annual interest on the outstanding amount.

h. In case of non-payment after the 10-day grace period, LFT reserves the right to use a debt collection agency or legal services to recover the debt.

i. LFT will only register students for exams if all tuition and exam fees are paid in full at the time of registration.

j. If the course fees are unpaid when the student leaves the academy, LFT reserves the right to withhold certificates or diplomas until all fees are paid.

k. Missed classes do not exempt the contracting partner from payment; there is no right to a refund.

l. Payment frequency cannot be changed from monthly to weekly/quarterly.

6. Termination of the Enrolment Contract for the New Academic Year by the Contracting Partner

a. The academy contract will automatically extend for an additional academic year (continuous contract) unless one of the contracting parties terminates it by email or letter with three months' notice before the end of the school year (19 June 2026). The date of receipt by LFT is decisive for meeting the deadline. The last day to terminate the contract for the following academic year is 19 March 2026.

b. If you wish to end the course within the last three months of the school year (19 March – 19 June 2026), you will be charged each month up to 19 June 2026.

7. Termination of the Contract During the Academic Year by the Contracting Partner

The academy contract may be terminated by the contracting partners by email or letter with three months' notice to the end of a month. In such cases, LFT is entitled to the total amount of monthly course fees for the entire notice period, even if the student is withdrawn before the contract ends.

Example: If you cancel on 18 February, you will be charged for the following three months – March, April, and May – up to 31 May.

8. Extraordinary Termination of the Contract by LFT

LFT may terminate the academy contract with immediate effect and without prior notice if:

- a. The student has seriously violated the academy's rules or committed a serious offence.
- b. The student repeatedly misses classes without prior notice.
- c. Other significant reasons make it unreasonable for LFT to continue the school contract.

In the case of extraordinary termination, LFT is entitled to an administrative fee (€80) and a cancellation fee equivalent to three months of course fees, in addition to the registration fee.

9. Class Schedules, School Holidays, and Public Holidays

- a. LFT management will determine class schedules and inform the contracting partners in writing in advance. The contracting partners are responsible for ensuring that the student arrives on time for lessons.
- b. LFT will inform contracting partners of school holidays and local/national public holidays before the start of the academic year or when they join LFT.
- c. All courses observe national, local, and school holidays (2 weeks at Christmas, 1 week at Carnival, and 1 week at Easter) throughout the academic year.
- d. An academic calendar is part of this contract; by signing the contract, you acknowledge having been informed of our school holidays. The calendar is also available at www.learningfirsttenerife.com.

10. Course Books and Other Materials

- a. Textbooks (student book, activity books, and homework booklets) must be purchased before the start of the course. Books can be bought at LFT.
- b. We use a digital platform where students must enter the code from their book to access digital resources. The digital code is valid for one academic year only.
- c. Students may access the platform from their own iPads at home. Minimal technology use will be applied in class unless students are enrolled in the programming course.
- d. Students will be invited to join an LFT class on the digital platform. This is a safe platform for student use; however, as it is online, minors must be supervised by an adult. LFT is not responsible for students' internet use at home while accessing the digital platform.
- e. The digital platform also allows parents/students to track their course progress. New books must be purchased each year to access digital resources.
- f. Students attending classes for extra help with schoolwork must bring their own books.
- g. Students must bring their course books, a notebook, and a pencil case containing a pen, pencil, eraser, and colouring materials to each class. Students should not bring toys, technology, or other personal belongings (such as books, mobile phones, computers, iPads, AirPods, etc.) unless mentioned above. LFT is not responsible for damage to personal items.
- h. Students must bring a water bottle to each class. If they run out of water during the lesson, they may refill it. Eating or drinking in class is not permitted unless for medical reasons.

11. Absences

- a. In the event of illness, contracting partners must inform the academy of the absence by phone, in writing, or by email.
- b. We do not make up classes missed for personal reasons or due to student illness. Only classes cancelled or postponed by LFT due to unforeseen circumstances will be rescheduled.

12. Camps, Additional Activities, and Overseas Trips

- a. LFT will announce these events appropriately and will also obtain explicit permission from the contracting partners.
- b. LFT students will have priority when booking places for camps and trips before these are made available to non-LFT students. A separate registration form will be required for camps and trips.

13. Insurance

By signing the academy contract, the contracting partners confirm that the student is insured against the consequences of accidents under mandatory health insurance. LFT has basic standard accident insurance for academic courses at LFT. The contracting partners provide the necessary insurance protection valid in Spain, including liability insurance.

14. Liability

LFT will not accept any liability towards the student or third parties, particularly in the event of accidents, losses, personal injuries, property damage, or financial losses of any kind, to the extent permitted by law.

15. Information on Adult Students

LFT may inform the contracting partners of an adult student about important academic matters, even without their consent, if they are paying the school fees.

16. Additional Provisions of Learning First British School SL

LFT reserves the right to cancel study courses, timetable variations, specialisations, or modules if there are insufficient students or other circumstances that make it unreasonable for LFT to carry them out. LFT also reserves the right to make changes to study courses or modules for important reasons while safeguarding the legitimate interests of enrolled students.

17. Final Provisions

- a. If individual provisions of the academy contract, the General Terms and Conditions, or their annexes are or become ineffective or invalid, this will not affect the validity of the remaining provisions. Ineffective or invalid provisions will be interpreted or replaced in such a way as to come as close as possible to the intended purpose of these agreements in a permissible manner. The same applies to gaps in the contract.
- b. Agreements between LFT and the contracting partners, as well as their supplements and amendments, must be made in writing to be valid.

c. Spanish law applies to all legal relationships with LFT. The place of jurisdiction is the registered office of LFT, although LFT is also entitled to take legal action against the contracting partners at their place of residence.

18. Data Protection

In accordance with the Organic Law on the Protection of Personal Data and Guarantee of Digital Rights (LOPDGDD 3/2018) and the General Data Protection Regulation (GDPR EU 2016/679), we inform you that the personal data contained in this document, or those collected during the course of the relationship, will be included in files owned by Learning First British School SL. They may be communicated to third parties solely for the provision of the agreed service. The purpose of processing such data is to establish the contractual relationship with this company. Authorisation is given through the consent of the data subject. You may exercise your rights of access, rectification, objection, restriction, portability, and deletion as provided for in the applicable legislation, or consult additional and detailed information on data protection by contacting the company.
